#### 1. When does this warranty apply?

This warranty is only available in Australia;

- The preventative servicing of products as per manufacturers and Macquarie Garage Doors' recommendations has been (iii) maintained by the customer.
  - (b) To the maximum extent permitted by law and provided the conditions in paragraph (a) are met, supersedes all other warranties, including any previous warranty you may have been issued.

#### 2. What do we warrant?

Shaliben Pty Ltd Trading as Macquarie Garage Doors will replace ( at MGD's option and in a manner MGD considers reasonable ) the parts covered by this warranty which fail to operate in accordance with the products installation and operation manual for a period of;

PLEASE NOTE - This warranty:

- (a) Is in addition to any statutory, non excludable guarantees or warranty rights and remedies under the law. See section 6 below
- (b) Applies to the original purchaser only and may not be transferred to others
- (c) Is subject to;
  - (i) The warranty conditions and exclusions as set out in sections 4 and 5.
  - You, complying with the manufacturer's instructions concerning installation, operation, maintenance and testing as set out in the manufacturers installation manual;

#### 3. Making A Claim

The following steps must be followed when making a claim under this warranty. To be entitled to claim under this warranty, the defect in the product must appear within the time frames stated in the above table ( if not listed in the above table refer manufacturers warranty as listed on website <u>https://www.macquariegaragedoors.com.au/manuals-guides-warranties</u>)

- (a) The product parts supplied and installed by MGD should be in accordance with the product manual for the time period shown or for the number of cycles, whichever occurs first (Residential based on 4 cycle average per day); provided you comply with the manufacturer's instructions concerning installation, operation and post installation maintenance. Failure to do so may void all or part of this warranty.
- (b) Contact Shaliben Pty Ltd Trading as Macquarie Garage Doors by email sales@macdoors.net or phone our office 02 49 422919
- (c) The customer is responsible for the cost of making a claim under this warranty. Any additional access expenses incurred by MGD where the product is not readily accessible must be borne by the customer.
- (d) You will need to provide proof or purchase, the product brand/model, original date of installation, evidence of post installation preventative servicing; and
- (e) Following a claim made in accordance with this warranty, if MGD confirms the product failure is covered by this warranty, MGD will replace parts and install at no cost to the customer.

#### 4. Warranty Conditions

It is a condition of this warranty that;

- (a) The product having been serviced by Macquarie Garage Doors within 2 years of installation (to allow for new doors to settle), (dependent on your product some may require servicing 12 months after original installation) and at least once every 2 years thereafter.
- (b) B&D products must have preventative services completed 12 months after original installation and every 2 years thereafter to maintain warranty.
- (c) Danmar, Tower, Signature, and Personality Custom Made Panel Doors must have preventative servicing completed every 12 months after original installation date to maintain warranty. Panel Doors exceeding 200kgs may require servicing every 6 months. MGD Salesperson will advise at time of purchase if this is required to maintain warranty.
- (d) This warranty will only apply to the original purchaser of the product and may not be transferred to other properties or new homeowners.
- (e) When products are sold by any person other than MGD, except for the warranty set out above, such person has no authority from MGD to give any warranty or guarantee on MGD's behalf in addition to the warranty set out above and;
- (f) It will not be extended for products or parts replaced under this warranty.
- (g) MGD's Extended Warranty to 7 years only applies to Gliderol Panel Glides and Gliderol A/AA Series Roller Doors subject to servicing requirements being met by the customer as outlined in 4a.
- (h) If preventative servicing is not maintained by the customer, warranty provided reverts to 2 years from installation date. It is the customer's sole responsibility to complete preventive maintenance to comply with warranty requirements.

#### 5. Warranty Exclusions

This warranty excludes defects or improper operation resulting from;

- (a) Higher than normal frequency of use, which may lead to excessive wear and tear; springs will need to be adjusted or replaced and the cost must be borne by the customer if you exceed those showing the table or preventative servicing is not maintained;
- (b) Accidental, deliberate or negligent damage, damage from impact or damage caused by insects, dirt, plants or any other objects;
- (c) Events such as beyond the measurable control of MGD including theft, fire, flood, rain, water, lightning, storms, earthquake or any other acts of God;
- (d) Water damage, salt, electrolysis, bubbling powdercoat/paint or other corrosion defects due to environmental conditions. Refer each particular manufacturer's coastline guidelines in regard to coastal environment warranty available. 800 metres direct line from nearest breaking water is not covered by warranty for above noted defects unless superseded by manufacturer warranty. Customer must wash down door with fresh water and soft cleaning sponge 4 times per year to help protect against above defects – for further individual information on particular product please view our website www.macquariegaragedoors.com.au/resources/warranties
- (e) The product not being installed, configured or used in accordance with the instruction manual or other unreasonable use, or failure to observe any instructions or directions provided with the product;
- (f) Manual locks not being removed from the door prior to installation of an opener. Any damage as a result of the manual lock will void this warranty for both the door and the opener;
- (g) The product being fitted with any closing device which is not the type of condition defined in the instruction manual as suitable for installation of the product;
- (h) Parts Of Garage Doors Excluded;
  - i. Key and Barrel 1 Year
  - ii. Panel Door Lifting Cable 1 Year from original installation/3 months if replaced with service work
  - iii. Panel Door and Roller Door Springs (Based on average 4 cycles per day single family residential
  - iv. Remote Control Transmitter 3 Months
  - v. Batteries
  - vi. Fuses
  - vii. Transmitter Range, Smartphone Connection Range, Receiver Range, Wi-Fi Range
- (i) For Danmar/Tower/Signature/Personality/Delta Panel Doors Frame Only or Part Cladded;
  - i. The warranty does not cover the customer's door cladding material; and
    - ii. The warranty of the frame only/part cladded will be null and void in respect of the product unless written evidence is provided that the customer had discussions with MGD prior to ordering of door frame whereby MGD has confirmed the suitability of the non-MGD cladding material for the panel door.
- (j) MGD's Extended Gliderol/Danmar Warranty Does Not Include the following on Gliderol Panel Glides, Gliderol A Series Roller Doors, Gliderol AA Series Roller Doors and Danmar Panel Doors (Only Danmar Panel Doors Supplied and Installed Between 1<sup>st</sup> January 2018-July 1st 2023 are eligible for 7 year extended warranty promotion )
  - i. Springs
  - ii. Panel Door Lifting Cables
  - iii. Roller Door Nylofelt
- (k) Unauthorised modifications or modification to bring a product into line with existing/future product performance and models;

- (I) Faulty installation of a product by a third party
- (m) Lack of proper maintenance, service or care of the product or servicing completed by a person not appropriately qualified to do so;
- (n) Installation of a residential garage door opener in a commercial or industrial premises or in a dwelling other than a single family dwelling

#### 6. Service and Maintenance Warranties

- (a) All service and maintenance works completed by Macquarie Garage Doors come with a 3 month labour warranty.
- (b) All Gliderol Panel Glide spare parts have a 3 month warranty (includes hinges, wheels, springs, lifting cable, bearing plates, locks, brackets)
- (c) All Gliderol Roller Door spare parts have a 3 month warranty(includes brackets, locks, hardware )
- (d) All Tilt Door spare parts have a 3 month warranty (includes springs, wheels, locks) 70J and 70T hardware if replaced as a whole kit have a 3 month labour and 2 year part warranty.
- (e) All Gate Opener spare parts have a 3 month warranty

#### 7. Statutory Guarantees or Warranties In Australia

If you are a consumer under the Australian Consumer Law, our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and fair compensation for any reasonably foreseeable loss or damage. You are also entitled to have the doors repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure. This warranty and other statements contained in any of our manufacturer's documentation about these products do not exclude, restrict, or modify the application to your other rights and remedies under the Australian Consumer Law. Subject to your non-excludable rights under the Australian Consumer Law, MGD expressly excludes any liability for consequential loss, incidental or indirect damages ( including but not limited to damages for loss of business profits, business interruption and loss of business information ) due to a defective product. Any loss or damage caused to other equipment or accessories used with the product or any loss resulting from a delay in replacement is excluded to the extent permitted by law.
